



Fig. 1. RMS on-state current as a function of heatsink temperature; maximum values




Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values





Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values





Fig. 7. Normalized gate trigger current as a function of junction temperature




Fig. 8. Normalized latching current as a function of junction temperature





Fig. 9. Normalized holding current as a function of junction temperature










Fig. 11. Normalized gate trigger voltage as a function of Fig. 12. Rate of change of commutating current as a junction temperature


